If you don't have TCC then it doesn't apply to sideline cheer. Fall acclimation period for Fall outdoor sports- limited to 2 hour for the first 5 days of practice. Starts when they hold their first official practice. Athletes joining late have to abide by the acclimation period. Football- (3) days of helmets, (2) days of helmets and shoulder pads . they may start August 5th. 10 Days of football before games. Bullet point sent to all schools for Fall beginnings.**
