### Athletic Directors' Council President's Report-Ken Perrotti

- A. Athletic Directors contact sheet **distributed to all ADs present**
- B. State Soccer coming 25-26 along with Cheerleading
  - a. **Have 24hrs to notify if your team is pulling out of competition otherwise a sanction or fine will be implemented.**
- C. Sportsmanship plaque to Monta Vista; Scholar athlete to Wilcox at **August BOMs**
- D. Pre-post meetings set by Commissioner, AD chairperson, reps. In stone, no movement, send a rep.
  - a. **Set at Post-season meetings and do not change. AD's in charge should communicate ASAP so everyone is on the same page.**
- E. Rep sheet for each sport 2024-25... GO TO post playoff meetings!
  - a. **3 spring sports didn't have reps is not a good look and can cause issues. AD's that oversee the sport ensure that reps are attending. Bylaws can be changed at Post Season League meetings and vote to approve by BOM**
- F. EAP-AED elements of focus CIF and CCS. **WetBulbGT live demonstration/expertise** by Professor Perrotti
  - a. **CIF requires every sport to practice EAPs. Document when your teams practiced their EAP.**
  - b. **AED within 3 minutes. Cross Country & Golf must be portable. Intent to AED for XC knowing they have one. Meets #2 and #4 will have AEDs with EMTs hired at Crystal Springs**
- G. Heavy conversation at CIF to have state start and end dates for each individual sport
  - a. **As they are rolling into more and more state championships this is getting closer. Past practice leagues set start and end dates, and then CCS. Now the State is trying to align. Some sections have no start dates for any sport.**
- H. CIF Model coach applications; to CCS 11/15 Commish has a copy; CCS Honor Coach GGolf, Soccer, Diving
  - a. **CIF Model Coach emailed and included to everyone. Submit to CCS. Not 1 person out of 155 schools last year nominated a coach.**
  - b. **CCS Honor Coach - Marcos sent out the information.**
- I. Choice Association for GIRLS' Lacrosse 24-25 to district office-
  - a. **School Board need to accept and approve the contract for those schools that have Girls' Lacrosse. At many schools Admin fees should be paid by the District so contract to Business office needs to happen. Document provided to ADs.**
