## Basketball

Proposal \#1: Allocation of CCS qualifiers to CIF NorCal California Regional Tournament. Use all twenty (20). Details will follow later.

## Soccer

Proposal \#1: Expand the number of divisions in both boys and girls soccer from (3) divisions to (5) divisions. (One (I) open and four (4) enrollment based.

- Recommended by CCS Soccer Committee, ADAC approved, League Commissioners approved.

Proposal \#2 : Change the tournament as follows: Subjective selection and seeding will be at a closed meeting with each basic league receiving one vote. Divisions 1-4 (non open) will be seeded by competitive equity using the current playoff point system.

- Recommended by CCS Soccer Committee due to the changes to the playoff calendar in 2018-19. ADAC approved. The League Commissioners did not recommend approval.

Proposal \#3: Award the (8) CCS berths into the CIF Northern California Regional Tournament in the following manner: Four (4) berths to the Open Division semifinalists, one (1) each to the champions of the other four divisions;

- The CCS Soccer Committee recommended this proposal to recognize those teams that are participating in more competitive Divisions. ADAC and League Commissioners approved.

Proposal \#4: Reclassify SCCAL Girls Soccer Stand-alone league from an A League to a B League.
