### Commissioner's Report

- A. CIF Model Coach application; CCS Athlete of the Year applications to SCVAL Commissioner by September 15<sup>th</sup>. No late applications will be reviewed or considered.
- B. Cheerleading TCC at CCS competition this year; CCS By-laws provided for TCC. (4) categories at first CCS Championship in January at Independence High. All TCC teams must register with CCS by September 15<sup>th</sup>
  - 1. The SCVAL at this time does not have a CSC spring league or schedule. Schools can participate as an independent or join another league as a supplemental if they wish
- C. Soccer Card-proactive approach. Examples provided to BOMs. They will be distributed to Soccer coaches at their preseason meeting. Palo Alto will make cards in other languages.
- D. How do you approach a female or male athlete who's swim suit is showing too much. The NCAA and NFHS approved statement is **"Fix your suit"**

- F. CCS Boys and Girls Lacrosse Championship proposal coming.

- H. Arbiter pay account
  - 1. Schools will NOT pay officials directly at each and every game
  - 2. Insurance will still be provided to districts from PSI-Contact PSI for your district document need.
  - 3. Admin fee's payment and costs remain the same.
  - 4. PSI has been informed that schools will NOT put money into their school Arbiter pay accounts before services have been rendered
  - 5. First step is to set up your school's Arbiter pay account in your school's Arbiter system. Do not put money in, utilize your school's EIN #
  - 6. Suggestion to make it work
    - Pay monthly. September 25<sup>th</sup> check Arbiter to your school's charges; check for correctness; if correct download those charges-**Use that as your backup for check request.** It will look like you are being charged a service fee but you are not officials will be charging you less. Cost to school's the same.
    - Put that amount in your Arbiter pay account
    - Wait 5 days make sure it is in account and push button to pay
