## President's Report-Bryan Emmert

A. CCS Winter Scholarship Teams nominations must be to CCS by February $1^{\text {st }}$. (See Document 1)
B. Monday, January 28th is the first day of Spring sports practice. Contests begin February 18th. Based on the calendar we will get back six (6) days next year. There is an overlap with Winter sports and contests over the upcoming break. This may create the need for increased awareness at facilities sites.
C. Public Health Guidance-AQI Reader. Prior to this year there has not been a policy or guidelines. It is unfortunate but we clearly need to prepare for future events. The availability of AQI readers for as little as $\$ 100$ was discussed. Measuring air quality of indoor facilities is necessary and varies based on ventilation, filters, fans and HVAC systems.

- The SCVAL is not responsible for establishing a policy or guideline.
- District Superintendents and/or each Schools' Administrators will ultimately be responsible for determining if a practice and/or contest should be cancelled due to poor AQI and what that standard is and when/where it is to be measured.
D. Later ends of school day-Visiting team waiting areas. Establish a process for meeting or directing visiting teams when they arrive at your facility is a must. There were some problems last Football season. Later release times for some schools may conflict with arrival times for visitor teams. Supervision should be provided by the visitors' coaches, who are often arriving significantly after the students. This is especially a problem for sports where visitors are providing their own transportation and not coming on a team bus. Please reinforce to your Coaches that there should be a plan in place at your site and when their team is visiting another site.
E. Cheer-CSC Spring sport. BVAL is forming a league for Competitive Stunt Cheer in which our schools may request to be "supplemental". Please contact the Commissioner for the required release. Sideline Cheer has an event at Independence High on February $2^{\text {nd }}$. Please see documents 3 and 4 in your file for more information on this growing sport.
a. Discussion was held. The NCAA is adding Stunt Cheer as a sport. This creates opportunities under Title 9 and likely will make the sport more popular at the high school level. Our schools continue to offer Gymnastics as an alternative but there may be pressure in the future.
F. Swimming-Competition suits at meets are purchased for speed but are too revealing and not allowed on deck. Please ensure that suits purchased are reasonably modest.
G. April 3-7 CSADA Conference in San Diego at the Town and Country. The Conference is a good way to provide leadership training for your Athletic Directors.

B. NCLRA Contracts...PSI versus SJUSD, LOUSD; our supplemental schools

- The contract with NCLRA included Admin fees, travel fees and required prepayment which was not acceptable. Schools may enter into their own contracts with NCLRA for Boys La Crosse since the SCVAL Commissioner will not agree to their terms.
- Several other leagues have declined to use PSI and have instructed coaches that they are precluded from using them. There are four (4) supplemental Girls' La Crosse teams in our league that this affects. For this season only, they may use other officials for contests at their sites.
- We have a - year contract with 2 years yet to run. Discussion arose regarding dissatisfaction with PSI and pursuing options to eliminate them.
