#### Athletic Directors President's Report-Jeff Lamb

- A. SJUSD Girls' Lacrosse schools leaving SCVAL. They are forming their own league with four (4) teams. We will now be one (1) division with seven (7) teams. BVAL is forming their own league and putting them in it for Girls' Lacrosse only.
- B. Wilcox will play an independent schedule next year in Field Hockey but will join our league in the following season. Valley Christian will also play an independent schedule next year. This may mean we will lose our four supplementals the following year, but Fremont, Gunn and Mt View may start field hockey.
- C. Constitutional Language-Vote to approve change/insert the-ejection policy (Attachment #1) Approved 12-0
- D. A copy of the BASO contract for the 2019-2020 and 2020-2021 school years is attached. Please provide the name of appropriate contact person for each district.
- E. Reminder that it is important that a Visiting Team waiting area be established. Someone should welcome opposing reams and remind them of their responsibility to have early bus/early parent/friend or athletes traveling together to be cognizant of the disruption to classes still in session.

**Spring sports reports**-Each AD in charge provided league standings, movement recommendations, by-law change recommendations, all league players' names and their draft schedule for 2019-20. Those reports are attached. All votes on proposed movement and proposed by-law additions/deletions were approved 14-0 unless indicated.

- A. Badminton
  - Proposal to add system to determine tournament champion at league finals. (13-0)
- B. Baseball
  - Proposal to change playing at visitor's site in lieu of home site, if field conditions warrant, for only LAST week of league. (13-0)
- C. Boys' Golf
  - Proposed addition to Article VI, Section 7 addressing Coaches giving advice during play in league matches passed with a vote of 13-1.
  - Local rule for lost ball and out of bounds is in effect for league matches (13-0)
  - Coaches may play players out of order if other coach notified half hour before. (13-0)
- D. Boys' & Girls' Lacrosse
  - The ADC revised the proposed amendment to start times to reflect that the Boys' and Girls' start times will be consistent with each other and will be as follows:
    - No field lights start times: Varsity 4:00, JV 5:30.
    - Lighted field start time: JV 5:30, Varsity 7:00.
  - There was discussion regarding the controversy over helmets being worn and the impact on the aggressiveness of play. It was decided/requested that the Commissioner should send a letter to CCS requesting that they take a stance prohibiting the use of hard-shell helmets in Girls Lacrosse. This committee will revisit its position in the Fall, after CCS has responded.
- E. Softball
  - Proposal to continue Varsity use of CCS ball but JV may utilize any ball home team wishes. (13-0)
  - Proposal to allow home team to not have media box in field of play. (13-0)
- F. Swimming
  - A proposal was brought forth by the ADC, and passed by a vote of 13-1, to add language to the by-laws for rotating sites for League championships. The by-laws should reflect that the De Anza and El Camino Leagues' championships will be combined at one site to rotate annually, with diving held at a Palo Alto. Each team will provide four (4) volunteers to assist with timing etc. with the exception of Wilcox and Santa Clara, who will each provide five (5) since they will not be in the rotation. Gunn has volunteered their site for 2020. (one-year pilot program) (13-0)
  - The revised by-law for start times for all league dual meets will be 4:00 unless the site does not have lights, in which case the start time will be 3:30.
- G. Boys' Tennis
  - Universal by-laws for Boys' and Girls' in place (13-0)
- H. Boys' Volleyball
  - no proposed changes
- I. Track and Field
  - Divisional finals field events to start at 4:00 (13-0)
- J. Gymnastics and Cheerleading-
  - No changes at this time
